

Dear Coach,

The Napa Valley Joe DiMaggio Baseball League will again sponsor the 32nd Annual Keith Connelly 4th of July Invitational Tournament. This year's format will again be a 16 team round-robin with the games being played at the Veterans Home in Yountville, Napa High School and Justin-Siena High School.

The dates of the tournament will be from Wednesday July 2nd through Sunday July 6th. All teams are guaranteed 3 games as each team will play all teams in their pool with the winner advancing to the finals on the 6th of July. The times and dates are included in this mail out. If there is a problem let me know as soon as possible. A tie breaking method will be announced prior to all the games. Individual awards will be awarded to the Championship and runner-up teams and team trophies to the top 2 finishers. An All-Tournament Team will be selected along with the MVP and MVPitcher.

The cost to play this year will be \$ 325.00 per team plus a dozen baseballs (good ones). Also we require a \$ 100.00 non-refundable deposit no later than June 1st or your team may be dropped. Rosters are due to me no later than June 20th so we may include them in our Tournament Program. Please list number, name and league age for all players. My fax number is 707 255-1334.

TOURNAMENT RULES:

1. Team make up is any Joe DiMaggio team with 21 players that you wish to bring that are 19yrs or younger with August 1st the cut off date. No more than three 19 year olds.
2. The High School slide rule will be in effect
3. Designated Hitter for the Pitcher only (American League Rule)
4. 14 innings per pitcher total in the Tournament (1 pitch = 1 inning)
5. Courtesy runner for the catcher only with 2 outs (optional)
6. No re-entry (except for injured players if the bench has been cleared)
7. Seven (7) inning games
8. Teams **MUST** arrive 45 minutes prior to their scheduled game time.
9. All Teams and Coaches must be in proper uniform to be on the field.
10. Ten run rule in effect after 5 innings
11. Time limit on all games to be 2 hours and 20 minutes.
12. **SPORTSMANSHIP** is very important and must be followed.
13. Any Coach/Player ejected will sit at least the next game
